

for sustainable land-use development and
governance in the Global South”**

September 25 – 29, 2023, in Tharandt, Germany

Seminar contents and aims

Over recent years, governance as theoretical concepts and practical tool has increasingly received attention as key to sustainable management of land resources, including forests and forest landscapes. Conceptually, governance refers to the interplay of norms, structures and processes that define how responsibilities are distributed and decisions are taken across multiple scales, sectors and by the associated actors such as international organizations, national ministries, local governments, civil society, the private sector and local communities. Power, which manifests in the actors' relationships and interactions, can be defined as the actors' capabilities to influence other actors within the governance regime. In this respect, power is critical for actors to efficiently operate in governance regimes, pursuing their interests against competing actors or forcing alliances for coordinated actions. Given the importance of actors and power, approaching governance from an actor-centered perspective is not only relevant for explaining specific land use outcomes, but also for identifying leverage points to change governance arrangements and to empower actors in a way it could promote sustainable land use practices.

Against this background, “actor-centered power (ACP)”, which is both a theory and a tool to rapidly assess actors' power, provides an appropriate approach to capture the outcomes of land-use governance regimes from an actors' perspective. This alumni strategy workshop gathers together alumni and other experts, who have integrated ACP approaches in their work as scientist and practitioners. Designed as strategic multiplier workshop, the event provides opportunities for intensive exchange and discussions on past, present and future use of ACP in land-use development and governance.

Beyond the professional exchange, the workshop aims at further developing the alumni expert network “Integrated Natural Resources and Environmental Governance” (INREM). The workshop seeks to further consolidate coordination mechanisms and to develop an agenda/roadmap for the alumni network with potential activities in the years to come. This includes the next two regional alumni networking and capacity building seminars, which are planned to take place in Latin America (2024, Argentina) and Asia-Pacific (2025, Indonesia), both dealing with regional natural resources governance dynamics as cross-country learning exchanges.

1. ACP-introduction and experience sessions


The main focus of workshop day 1 are the two sessions entitled “Actor-centered power – concepts, methods and case studies” which serve as gateway into workshop topic. In these inceptive sessions you have 5 minutes to introduce your very personal experience with the actor-centered power (ACP) approach/concept and how you made use of it in your research. Please be rather short and to the point, and prepare your input along the following guiding questions:

- In which context did you use the ACP approach/concepts (country, case study, context)?
- What was the objective and research question(s) about?
- Why did you consider ACP as an appropriate approach for your research?
- By what kind of methodology and research design did you operationalize your ACP-research?
- What were the results and how did you interpret them in the context of ACP?
- How did your research contribute to the further development of ACP theory?
- What are your lessons learnt in positive and negative sense?

!!!! There is no need to prepare any power point presentation for this session !!!!

2. ACP paper-sessions

The workshop days 2 to 4 will be mainly devoted to paper sessions on ACP-related research. In individual paper session you are provided the opportunity to briefly present and intensively discuss your recent or ongoing ACP-research and get feedback from your peers. Each paper session (90 minutes) comprises two papers. For each paper we will devote 45 minutes in the following procedure:



For each paper we will assign peer-reviewers who will provide short comments (5 minutes each reviewer) before the floor will be open to take further questions, comments and discuss the paper. We expect that all workshop participants will read all the papers in advance. Please note that during the session authors will only present the major points so that we have sufficient time for feedback and discussion.

3. External critique session

Workshop day 4 includes a session in which we will jointly deal with the external scientific feedbacks on ACP-related research you received in peer-review processes over recent years. In this session we will collect and critically reflect on these review feedbacks. As input for the discussion, thus, please bring along some of the key critical remarks and comments on ACP you received in review processes. The collected criticism will be used for a critical self-reflection on our work as initial point for a joint article in which we scrutinize and further advance APC-theory and methodology.


