# Data Protection Declaration / Declaration of Consent for the DAAD Award Application Procedure

## 1. purpose and data collecting agency

In recognition of the fact that foreign students enrich the university community at German universities both culturally and academically, the German Academic Exchange Service (DAAD) provides universities with annual funding for the "DAAD Prize for Foreign Students at German Universities".

Every year, a foreign student at the TU Dresden is awarded this prize. The prize, which is endowed with 1,000 euros, is intended to honour an outstanding foreign student who has distinguished himself/herself through both special academic achievements and remarkable social or intercultural commitment. The award winner is selected internally by the university.

## 2. data processing

The declaration of consent includes the processing of the following personal data:

Name, degree programme, semester, date of birth, nationality, grade point average, grade overview, information on social commitment, address, special academic achievements, matriculation number, faculty.

#### 3. <u>anonymity</u>

The data collection is personal. This means that conclusions can be drawn about you on the basis of the data collected, in particular your name, place of residence, study history, social commitment, academic achievements. Data will not be made anonymous.

#### 4. data transfer

Data will be passed on to the five representatives of the TU Dresden who sit on the selection committee. The representatives come from the following offices/areas:

- International Office
- Vice-Rector Academic Affairs
- Vice-Rector University Culture
- Chief Officer Technology Transfer and Internationalization
- Student Counsil TU Dresden

## 5. <u>publication</u>

If you are awarded the DAAD Prize, your name, degree programme and country of origin will be published at the award ceremony and together with a photo in the subsequent press coverage.

#### 6. Voluntariness and revocation (Art. 7 para. 3 GDPR)

The provision of personal data is voluntary. Consent can be refused or revoked at any time informally and without giving reasons to the person responsible. Your personal data will then no longer be processed. The legality of the processing carried out on the basis of the consent until the revocation remains unaffected by this.

## 7. Right to information (Art. 15 GDPR)

You have the right to request information about the personal data processed about you and the possible recipients of this data at any time. You are entitled to a response within one month of receipt of the request for information.

#### 8. Right to rectification, erasure and restriction (Art. 16-18 GDPR)

You can request the correction or deletion of your personal data or the restriction of processing at any time from TU Dresden.

## 9. Right to data portability (Art. 20 GDPR)

You may request that the controller transmit your personal data to you in machine-readable form. Alternatively, you can request the direct transfer of the personal data you have provided to another controller, insofar as this is possible.

## 10. Right of appeal (Art. 77 GDPR)

Affected persons can contact the Data Protection Officer of TU Dresden at any time and, in the event of a complaint under Art. 77 GDPR, the competent supervisory authority for data protection. The competent supervisory authority is: **Data Protection Officer of Saxony**
